Subject: The Statement made according to the Official Rules Statement of Capital Market Board Regarding the Announcement of Special Conditions to the Public (Serial: VIII, No: 54).

It was announced to the public with our Special Condition Statements dated January 31 2011, February 14 2011 and February 24 2011, respectively, that agreement could not be reached in the official negotiator process in the labor agreement negotiations regarding the new period (September 1 2010 - August 31 2010) conducted between MESS TURKISH METAL INDUSTRIALISTS UNION of which we are a member and UNITED METAL WORKERS UNION of which our personnel consist in, strike decision was made for our company workplace by the labor union and MESS TURKEY METAL INDUSTRIALISTS UNION Board of Directors have decided on lockout in our workplace to be separately identified later according to the application date requirement.

The Labor Agreement that covers the September 1 2010 / August 31 2012 period has been signed on April 15 2011 and the information of its signing has been conveyed to our company today via fax.

Accordingly, the wage increases shall be as follows:

- 1. Increase:** For workers who are working in the workplace as of 01/09/2010 and have their service contract continue at the time of the signing of agreement; a fixed rate increase of 5,35% of the workplace average on 31/08/2010 over the hourly wage they are receiving as of 31/08/2010 is made by 01/09/2010.
- 2. Increase:** For workers whose service contract continues as of 01/03/2011; a fixed wage increase proportional with the TÜİK Consumer price index increase ratio between 01/09/2010-28/02/2011 of the workplace average of 28/02/2011 made to the hourly wage they are receiving as of 28/02/2011.
- 3. Increase:** For workers whose service contract continues as of 01/09/2011; a wage increase proportional with the TÜİK Consumer price index increase ratio between 01/03/2011-31/08/2011 to the hourly wage they are receiving as of 31/08/2011 is made on 01.09.2011.
- 4. Increase:** For workers whose service contract continues as of 01/03/2012; a wage increase proportional with the TÜİK Consumer price index increase ratio between 01/09/2011-29/02/2012 to the hourly wage they are receiving as of 29/02/2012 is made on 01.03.2012.

We announce that our statements above are in conformance with the rules of Board's Official Statement of Serial: VIII, No: 39, that it completely reflects the information we have obtained on this matter(s); the information is in conformance with our books, registers and documents, we showed due diligence to obtain the information regarding the matter completely and correctly and we are responsible for these statements made.
