Subject: The Statement made according to the Official Rules Statement of Capital Market Board Regarding the Announcement of Special Conditions to the Public (Serial: VIII, No: 54).

It was learned that, regarding the tax loss penalty, tax loss and irregularity penalties of a total of 10,183,104.16 TL which is present in the Tax Penalty Notifications of Mudanya Tax Office Directorate regarding 2002;

- that we received these notifications with our Special Condition Statements dated December 31 2007 and January 30 2008,
- that we filed for their cancellation to Bursa Tax Court with our Special Condition Statements dated January 29 2008 and January 31 2008,
- and with out Special Condition Statement dated May 14 2008 that it was learned that seizure was placed to the land register of the real estate which is registered on Ömerbey Mahallesi Sheet 32/34 Block: 175 Parcel: 20 which houses our company's Mudanya manufacturing facilities by Mudanya Tax Office Directorate regarding the tax loss penalty, tax loss and irregularity penalties amounting to a total of 10,183,104.16 TL which is present in the Tax Penalty Notifications of Mudanya Tax Office General Directorate,
- with our Special Condition Statement dated March 2 2009, it was decided by Bursa 2nd Tax Court that subject matters of the prosecution was not legal and our appeal was accepted; the actual tax and on layer tax loss penalty value added assessments and special irregularity penalty to be removed with the path of appeal by State Council being open,
- With our Special Condition Statement dated April 20 2009 that it was learned by our Company that Bursa Tax Administration has appealed before the State Council for removal of this decision,
- and with our Statement dated April 15 2010 that our Company learned that State Council ruled on January 19 2010 against the appeal request of Bursa Tax Administration and decided for approval of Bursa 2nd Tax Court for our company's benefit.

Today it is learned with the notification we received from Mudanya Tax Office Directorate that the seizure placed on the real estate registered to Ömerbey Mahallesi Sheet 32/34 Block: 175 Parcel: 20 which houses our company's manufacturing facilities by Mudanya Tax Office Directorate in 2008 was lifted with Title Deeds Registry Office's writing dated 01/04/2010 and journal number 3327.

We announce that our statements above are in conformance with the rules of Capital Market Board's Official Statement of Serial: VIII, No: 54, that it completely reflects the information we have obtained on this matter(s); the information is in conformance with our books, registers and documents, we showed due diligence to obtain the information regarding the matter completely and correctly and we are responsible for these statements made.
